Compilation of Clery Report Complaints Against the California State University System and Individual Campuses

System wide

1. Source – Los Angeles times article May 10, 2000 via Security on Campus letter May 11, 2000.
Detail – The “secretive systems” of internal campus judicial systems deprive students and parents of information about misconduct (crimes).
2. Source – Los Angeles times article May 10, 2000 via Security on Campus letter May 11, 2000.
Detail – Sexual Assaults are underreported based on the gap between the number of sexual assaults reported to campus women’s centers and the number appearing in official university crime statistics.

Fullerton

1. Source – Security on Campus letter May 11, 2000.
Detail – The campus keeps no statistics from disciplinary proceedings.
2. Source – Los Angeles times article May 10, 2000 via Security on Campus letter May 11, 2000.
Detail – The institution keeps no statistics from its internal disciplinary system (Student Conduct Office) and chooses not to compile those statistics.

Sacramento

1. Source – Women Escaping a Violent Environment (WEAVE) letter July 5, 2000.
Details – The Campus Security Report (alternately the Clery Report) did not contain required sexual assault policies (victim’s right’s provisions)
2. Source – WEAVE letter July 5, 2000.
Detail – The Clery Report did not contain any statement about the monitoring of alcohol violations at student organizations off-campus.
3. Source – WEAVE letter July 5, 2000.
Detail – CSUS failed to comply with the requirement to distribute the report to all students. The student attended CSUS for two years and never received a Clery report and after informal interviews with numerous students on campus, found no evidence that the report was distributed.
4. Source – Security on Campus letter October 2, 2000 and Sacramento Bee article September 24, 2000.
Detail – The only crimes statistics included in the Clery report were those that had been reported to campus police and the student affairs department.

Chico

1. Source – Los Angeles times article May 10, 2000 via Security on Campus letter May 11, 2000.
Detail – A student, who was taken to the campus police to file an assault complaint, was not involved with or informed of the resolution of the disciplinary process.
