
Dr. C. Timothy Summerlin asked that I respond to your letter dated March 5, 2008. Attached you will find a transmittal form delineating the documents you requested. Schreiner takes seriously its obligation to report openly and honestly about crime statistics as required under the Clery Act. We comply with letter and spirit of the Clery Act scrupulously. The alleged incident you referenced was not reported because we have not received any details of the alleged crime either from the accuser or her parents. The complaint to the Department of Education by the family and their counsel appears to be an effort to harass and intimidate Schreiner into making a cash offer.

The only details we have received of an alleged crime were in the lawsuit, filed over two years after the alleged incident. I can only surmise that the counsel for the plaintiff wants us to report a crime to bolster her claim against the university.
